

## 2022 Gospel Music Industry Hub Release, Sales and Distribution Agreement (Musician)

For the purposes of this document, the submitting songwriter is referred to as the "Artist."

This release form entitles the Gospel Music Industry Hub (GMI Hub) to use the referenced sound recording for broadcast publication on radio, television, Internet, or other accessible media for public use.

This document confirms the agreement between the Artist and the Gospel Music Industry Hub for use of the referenced Song/Album Compilation, Band/Artist name, and images associated with Artist in broadcast publications. This form is to provide authorization for the Gospel Music Industry Hub to use Artist images and songs in order to help promote Artist's music and the above stated GMI Hub Compilation project

Specifically:

- I. **Ownership:** The Artist warrants that:
  - a. The above referenced sound recording and its copyrights belong exclusively to the Artist.
  - b. The Artist knows of no disputes or encumbrances affecting ownership.
  - c. The Artist has the right and authority to make this agreement and believes it to be enforceable.
- II. **Recording Release:** The Artist agrees
  - a. The song has not been previously released before November 4, 2022. The artist may self release on or after November 4, 2022
  - b. The sound recording identified above can be used for broadcast release to the general public on radio, television, Internet, or other accessible media for public use.
- III. **Distribution of Goods Agreement:** This form also authorizes the Gospel Music Industry Hub to make the Song/Album Compilation available for retail sale of \$10.00 per digital format album or \$15 per physical cd plus applicable shipping. Artists may purchase a minimum of five (5) physical cds at the wholesale price of \$10/cd plus applicable shipping. The Gospel Music Industry Hub will sell the GMI Hub Compilation Album to the public. The Artist's Song and the GMI Hub Compilation Album will not be made available for free downloading.
- IV. **Distribution of Sales Revenue:** The Artist accepts the following distribution of revenue from the sales of the Song/Album Compilation on the Gospel Music Industry Hub:

- a. The Digital Album Compilation will be sold for \$10.00. Total sales revenue will be split as follows: 20% Administration Fee; 40% to the Artist; and 40% to Gospel Music Industry Hub.
  - b. All physical cd sales will be based on the wholesale price of \$10/cd. Total sales revenue will be split as follows: 20% Administration Fee; 40% to the Artist; and 40% to Gospel Music Industry Hub.
  - c. The Artist is responsible for split payment of their revenue portion to co-writers, musicians and producers where applicable.
  - d. **Pay Out Schedule:** Revenues will be distributed to Artist on or around March 1, 2022. Sales payments will continue in perpetuity paid annually on the 1st of March until the album is no longer being sold by GMI Hub.
- V. **Royalties:** GMI Hub has no claim on royalties or other payments to the Artist associated with the broadcast or use of this Song/Album Compilation. The artist is responsible for registering the song with a performing rights organization (SOCAN), obtaining ISRC codes (Connect Music) and registration with any companies for collection of license fees or royalties such as but not limited to: Re:Sound, Connect, MROC, SOCAN, CMRRA, RACS, and Sound Exchange. This revenue will go in full to the Artist for distribution to co-writers, musicians, and producers where applicable.
- VI. **Sales Promotion:**
- a. The Artist authorizes GMI Hub to promote the Christmas Compilation Album using social media and the GMI Hub network of subscribers.
  - b. The artist agrees to promote the GMI Hub Christmas Compilation Album through their social media and any other means available to the artist. Training and promotional material may be provided by GMI Hub.
- VII. **Use of Name and Images:** The Artist agrees
- a. The name of the Artist and the name of the Song/Compilation identified above can be used along with any related Song/Compilation or sound collections to identify the source of the Song/Compilation for promotional purposes expressly relating to the Gospel Music Industry Hub.
  - b. Any images – including album liner photos, trademarks, and publicity photos – or likenesses of the Artist related to the Song/Compilation identified above can be used in conjunction with or independently of the Song/Compilation for promotional purposes expressly relating to the Gospel Music Industry Hub.
